**Legal Aid Announces Two New Neighborhood Brief Advice Locations**

The Legal Aid Society of Cleveland's Volunteer Lawyers Program announces **two new service** locations for its Brief Advice and Referral Clinics: Good Shepherd Lutheran Church and Corpus Christi Church. The program, organized in collaboration with the Cuyahoga County Bar Association, and the Cleveland Bar Association's *Our Commitment to Our Community*, encourages private attorneys to assist in making legal advice and representation more accessible to low-income persons and families.

During the drop-in clinics, volunteer lawyers offer general advice, information or referrals to low-income families with civil legal issues, including predatory lending, housing, divorce, contracts and bankruptcy, as well as problems with public benefit systems. The attorneys do not handle criminal cases. Interested persons should bring all relevant paperwork:
